Terms of Sale:

If applicant's account should become delinquent or exceed the established credit limit set by Auto Custom Carpets, Inc., orders are subject to being shipped C.O.D. or held until applicant's account is within terms of sale.

Freight:

All freight is F.O.B. Factory Anniston, Alabama

Returns:

No merchandise may be returned to Auto Custom Carpets, Inc. without a factory issued authorization number. Within the first 90 days, returns for any reason other than factory error are subject to a 20% restocking/handling fee. After 90 days from date of shipment, there will be no replacement, exchange, or credit for any reason.

Government Law:

This agreement shall be governed by and construed in accordance with the laws of the State of Alabama. This agreement is the active agreement between parties and within respect to the matters defined herein and cancels and supersedes all prior written or oral agreements between the parties.

Service Charge:

You further agree to pay interest at the rate of 1-1.5% per month to Auto Custom Carpets, Inc., on any delinquent balance. Interest will be computed from invoice due date. Applicant agrees to pay for all collection and/or attorney fees, related costs, and subsequent interest charges for any balance placed for collection.
